- Current proof of residency from the Orange County Registrar of Voters
- Current DMV vehicle registration showing residency property address
- Current Property Tax or Income Tax Documents (from the IRS, State, and or County)
- Current Social Services Documents
- Current Payroll Stub (both name and address must appear on payroll stub)
